3. Congestion Management Process Update

Ms. Stephanie Rossi, of CORE MPO staff, reviewed the work to date on the Congestion Management Process (CMP) update and solicited feedback from the TCC. Topics included commute mode share, objectives, measures, data sources, existing conditions, travel speed analysis, as well as additional measures of 95th percentile travel time and travel buffer times for select corridors. The TCC members present concurred with the CMP approach presented by Ms. Rossi. They reviewed a list of potential corridors for the 95th percentile and buffer analysis and made recommendations. TCC members also suggested sources for GIS data on speed limit zones.
