Resolution to Update the FY 2021 – 2024 Transportation Improvement Program of the Coastal Region Metropolitan Planning Organization (CORE MPO)

WHEREAS, the Coastal Region Metropolitan Planning Organization (CORE MPO) has been designated by the Governor of Georgia as the Metropolitan Planning Organization of the Savannah urbanized area in accordance with federal requirements of Title 23, Section 134 of the United States Code to have a cooperative, comprehensive, and continuing transportation planning process; and

WHEREAS, CORE MPO adopted the FY 2021 – 2024 Transportation Improvement Program (TIP) on December 9, 2020; and

WHEREAS, CORE MPO desires to adopt updates to the FY 2021 - 2024 TIP for the CORE MPO Metropolitan Planning Area to reflect the updated information and the latest developments; and

WHEREAS, the proposed TIP amendments include updates to various highway and transit projects and programs as outlined in the TIP amendment staff report;

WHEREAS, CORE MPO has completed the public review and comment period for the proposed TIP updates according to the Participation Plan and addressed all comments received; and

WHEREAS, CORE MPO has conducted a public hearing for the proposed updates, and has taken into consideration comments made at the public hearing; and

WHEREAS, all requirements of the Participation Plan pertaining to TIP amendments and administrative modifications have been met.

NOW, THEREFORE, BE IT RESOLVED THAT, the Coastal Region Metropolitan Planning Organization approves the proposed updates to the FY 2021 - 2024 Transportation Improvement Program as shown in the summary of TIP update staff report with any corrections based upon the motion of June 22, 2022.

Updates to FY 2021 – 2024 Transportation Improvement Program June 2022

The Transportation Improvement Program (TIP) is the MPO's short-range programming document and is a staged, multi-year listing of surface transportation projects proposed for federal, state, and local funding within the metropolitan area. The TIP may be modified in accordance with the procedures outlined in the adopted Participation Plan by resolution of the CORE MPO Board if priorities, area goals, project schedules or funding levels change.

The current FY 2021 – 2024 TIP was adopted by the CORE MPO Board in December 2020 and is referenced in the Statewide TIP (STIP) which was signed by the Governor of Georgia in May 2021. The TIP has been updated in 2021 and 2022 through various amendments and administrative modifications.

It is important to make sure that the information contained in the TIP is current and reflective of the most up-to-date cost estimates and development schedules. The timing is particularly important for those projects/phases programmed in FY 2022 as this fiscal year ends on June 30, 2022. If a project/phase is being developed on schedule and the programmed funds in FY 2022 are expected to be authorized before June 30, no updates are necessary; otherwise administrative modifications or TIP amendments are needed to reflect the current project development status.

CORE MPO staff has coordinated with the project managers/sponsors on projects' development status. The omnibus status check is included in Appendix C. It is also important to amend the TIP to add new or delete existing projects/phases at the request of sponsoring agencies based on the project changes and MTP/TIP consistencies.

The following summary outlines the changes to the FY 2021 – 2024 TIP for June 2022.

AMENDMENT PROCESS FOR FY 2021 – FY 2024 TIP

It should be noted that the Transportation Improvement Program (TIP) must be consistent with the current 2045 Metropolitan Transportation Plan (MTP) called Mobility 2045. Before amendments can be made to the FY 2021 - 2024 TIP, MTP/TIP consistency must be verified. The TIP must also be conformant to the Performance Based Planning and Programming (PBPP).

The project updates (outlined on the next pages) are requested by GDOT, CAT and the City of Savannah for June 2022. Updated TIP project pages/tables for the highway and transit projects are illustrated in Appendix A. Projects/Phases requiring amendments, as opposed to administrative modification, to the TIP require a 15-day public review and comment period.

Public Participation Process

The adopted TIP/STIP amendment process outlined in the CORE MPO's Participation Plan requires public review and comment and responses to all comments (either individually or in summary form) for all TIP amendments. To process the proposed updates in June 2022, CORE MPO advertised a fifteen (15) day public comment period in the Savannah Morning News on Sunday, June 5, 2022 (Appendix B). The notice was sent to the local news media and the consultation agencies as well as neighborhood associations and posted on the CORE MPO website. The comment period started on June 8, 2022 and closed on June 22, 2022. A public hearing was advertised and held in conjunction with the CORE MPO Board meeting on June 22, 2022.

Action

The June 2022 updates to the CORE MPO FY 2021 – 2024 TIP were endorsed by the CORE MPO Technical Coordinating Committee (TCC) and the Citizens Advisory Committee (CAC) on June 16, 2022. The CORE MPO Board adopted the TIP updates at the June 22, 2022 meeting.

Project Description:	Reduce traffic congestion on DeRenne Avenue by providing a new four-lane divided connector from I-516 to a realigned White Bluff Road with a new direct connection to Hunter Army Airfield and a multi-use path. This project will more evenly distribute the 54,000 vpd on I-516 between east/west movements on DeRenne and north/south movements on White Bluff Road and Abercorn.		
Project Status:	Preliminary Engineering (PE) was programmed in FY 2018 and 2019 with Z230 funds, and the funds have been authorized. The Environmental Impact Statement (EIS) and Record of Decision (ROD) were sent to FHWA in April 2021. Final plan preparation is ongoing. In June 2021, the environmental schedule was pushed back. GDOT sent out the confirmation letter to shift the Right-of-Way funds (Z230 funds and local match from the City of Savannah) from FY 2021 to FY 2022. Additional PE funds (Z230 and HIP) were added to FY 2022 through April 2022 amendments and have been authorized. As of June 2022, the added PE phase for more EJ analysis will delay the project schedule again. Utility (UTL) and Construction (CST) phases are in long range.

Reason for Update:	Additional Environmental Justice (EJ) analysis will take at least 18 months to complete.

Project Description:	The City of Savannah is relocating their operations from the city lot on Gwinnett St to a new facility on Interchange Court. This will require that the existing TCC be moved to the new site. The City is partnering with GDOT to make the new facility connected to the GDOT system to provide a more regional operation that incorporates data from the City's TCC. The costs associated with the project are for equipment, fiber installation extensions, consulting, and software to make the new operation compatible with the GDOT system. This new facility will place the City of Savannah more in line with other agencies in the Savannah MSA and allow for future growth of the system into a regional center. The new TCC will encompass approximately 2,500 square feet.

Project DeRenne is one of those projects and the Federal Highway Administration (FHWA) directed the local sponsor, the City of Savannah, to perform additional outreach to the EJ community. Since January 2022, the City of Savannah, Georgia Department of Transportation and FHWA have discussed the need for the additional outreach and the plan to implement such. To that, the consultants for the project have revisited the timeline required to accomplish this additional outreach and believe that to be approximately 18 months.

The City of Savannah is requesting your office allow the funds programmed in Fiscal Year 2022 to be rolled over to Fiscal Year 2023 to help with the unanticipated delay in the project schedule. The design team and GDOT staff have worked diligently to make the programmed schedule, but the insertion of this additional outreach requires movement of the funding and may even push into Fiscal Year 2024.
