Mr. Marcus Lotson gave the following report:

Nature of the Request: The petitioner, Daniel Snyder, is requesting approval of a 37 foot 9 inch marsh buffer variance from the 50 foot requirement in order to construct a swimming pool. The subject property, located at 6 Marsh Haven Lane, is within a PUD/EO (Planned Unit Development / Environmental Overlay) zoning district. The proposed pool addition is a part of a home remodel curently underway.

Background: A separate marsh setback varinace was granted for this project at the November 24th 2009 hearing for the purpose of accommodating a support structure for an upper story deck. The Board at that time continued the swimming pool portion of the request until such time that the petitioner could statisfy the Board's concerns regarding drainiage as the impervious area would be increased by the installation of a pool.

Staff recommendation is for denial of the petition.

Speaking on the petition: Mr. Daniel Synder, agent for James and Amanda Hochman, distributed revised copies of the proposed plan to Board Members. He gave a brief presentation on the revisions and there was a period of questions and answers.
